# **Project Overview**

- Upgrade 5.5 miles of existing 12kV distribution line with 69kV and 12kV cables
- Constructed in three phases
  - Phase 1 Double-circuit 69kV/12kV underbuild
  - Phase 2A Double-circuit 69kV/12kV underbuild
  - Phase 2B Single-circuit 69kV/12kV underbuild
- Requires 140 replacement poles and 10 new poles
- Anticipated construction time of 12 months
- Construction to begin in October 2024






### **Project Benefits**
